

I. Total construction work completed

In January-March 2025, the volume of construction work completed in the Republic of Uzbekistan amounted to 50 284.6 billion soums, which, in relation to 2024, is 110.8%.



II. Construction works by types of economic activity

Construction work in the Republic of Uzbekistan for the specified period is distributed by types of economic activity as follows:

- the share of construction of buildings and structures reached 71.6%, which, compared to 2024, amounted to 108.4%;
- the share of construction of civil facilities was recorded at 18.7% and, if compared with 2024, it amounted to 117.5%;
- The share of specialized construction works is 9.7% and, compared to 2024, this amounted to 117.3%.



III. Structure of the volume of construction works by types of enterprises




The volume of construction work performed by large construction organizations in January-March 2025 amounted to 11 020.3 billion soums. Compared to 2024, in the period under review, the volume of construction work amounted to 131.9%, and their share in the total volume increased by 3.5% and amounted to 21.9%.

The share of construction work performed by small enterprises and microfirms in the period under review amounted to 48.2% of their total volume. Thus, the total volume of construction work performed by them amounted to 24 221.2 billion soums and, in relation to 2024, it reached 107.1%.

The share of construction work in the informal sector amounted to 29.9%, or 15 043.1 billion soums, and, compared to the same period in 2024, it reached 104.3%.

High growth rates of construction work performed by large construction organizations were noted in Andijan (266.1% of the corresponding period of 2024), Jizzakh (228.2%) and Tashkent (192.2%) regions.

Significant growth rates of construction work performed by small businesses and microfirms during the period under review were recorded in Samarkand (115.1% of the corresponding period in 2024), Fergana (110.2%) and the Republic of Karakalpakstan (107.7%).

IV. Metadata and explanations for statistical indicators on construction works

Construction works – this is the result of construction production as a complex of works performed during the construction, reconstruction, expansion, major and current repairs of buildings and structures.

The cost of construction includes work on site development, sanitary and technical work on water supply, sewerage, installation of building structures, and other contract work (commissioning, cultural and technical, etc.).

Statistical accounting of construction works is carried out in the amount of the volume actually completed during the reporting period, regardless of the moment of its payment in actual prices of the reporting period, without value added tax.

The formation of statistical information on the volume of construction work is carried out on the basis of:

- a) statistical reporting (monthly, annual) of legal entities engaged in construction activities:
- b) results of quarterly sample surveys of the activities of small enterprises and microfirms;
- c) statistical reporting of territorial offices of the Chamber of State Cadastres, monitoring the construction of individual housing and non-residential properties by individuals;
- d) data from sample statistical surveys of individual residential buildings put into operation:
- e) statistical assessment of the volume of repairs to individual residential buildings carried out using private methods.
